EduClimber Overview - A. Uberti

A. Uberti provided an overview of the EduClimber platform which pulls in data from other platforms. Most data is on an automatic upload and is updated each night. Some data is manually uploaded. A. Uberti logged into EduClimber to demonstrate the way it creates visualizations that help teachers and leaders interpret that date more easily. She explained that it can be used to look at district or school performance on various measures. It can also be used to look at individual student progress. Data can also be easily disaggregated to monitor the performance of certain groups. She also showed how it is being used to monitor MTSS. Interventionists create MTSS plans in EduClimber, identify the progress monitor and then track students performance throughout the intervention to evaluate its effectiveness. Right now it is being used by building leaders, interventionists and counselors at the K-8 level. She is expecting to roll it out to teachers next year as well as to the high school leaders.
